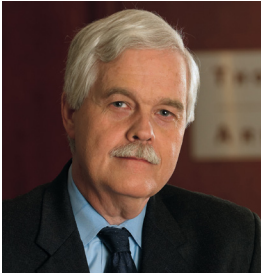
Andy Perlman

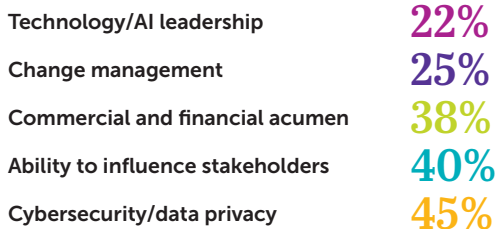
