Fellows Profile Sally Fiona King

How did you get started in the legal profession?

In the early 80's I worked for a small NYC law firm, because I though it would provide me with the insight I needed to decide whether to go to law school. As a result of that experience, I realized that business school was a better option for me! I attended Columbia University's Executive MBA program and shortly thereafter was recruited by Ben Heineman, then General Counsel for GE, to be the business manager for the GE Legal Organization. The rest, as they say, is history.

How did you end up in your current position?

The firm I was with previously, Kronish Lieb Weiner & Hellman, merged with Cooley Godward in the fall of 2006. A month later, I was in the back of a town car sharing a ride with a leading NYC search consultant (Lyn Mestel). She asked what I was planning to do next. Upon hearing that I wanted to continue in a similar capacity, she exclaimed that she had "the perfect position." A few weeks later I met Craig Medwick, the Managing Partner for the Americas, and the rest of the executive team here at Clifford Chance, and I knew she was right. It all fell into place pretty quickly after that.

What has been the most surprising aspect of your career?

That I truly love what I do. I am never bored because every day is different. As the legal profession evolves, so too does my role. My work continues to challenge and excite me. I really look forward to coming in to the office each morning.
