He did many things for many people, and to him it was important and worth it to do things for others. He will be remembered by me and those he knew for his caring, thoughtful ways. # Legal Services Corporation Pilot Program A Success!

As the College celebrates the end of the first year of our collaboration with the Legal Services Corporation (LSC), we want to provide you with an update and an invitation. But, first, we must acknowledge the contributions of the late Jim Lantonio. He was a wonderful supporter of this project, and we benefited greatly from his wisdom and insight. We will miss him very much.

Our collaboration began when the boards of the LSC and the College agreed to begin a volunteer project to apply some of the knowledge of College Fellows to some of the challenges faced by LSC. LSC provides over \$400 million in grants to 137 independent nonprofit legal aid programs with 900 offices that provide legal families across the country. These law offices have all the practice management challenges that other law offices have: staffing; technology; management; marketing and communications; and the like. Our pilot program was organized under the supervision of the LSC Office of Program Performance as part of its regular annual series of Program Quality Visits.
